However, a certificate dated 03-12-2021 amendment in school name has been uploaded by school on its website under mandatory public disclosure section. Thus, the school is directed not to remove the same from its website in future. 5. The school is required to set-up Mathematics as per dimension given in Affiliation Bye-laws and upload the videography of the same on the school website under mandatory disclosure section 6.
